Equine Medication Control Fines and Penalties

Infractions will be determined by a positive certificate from the official laboratory signed by the lab technician.

Infraction	Rule/Policy	Fine/Penalty
Infraction Class 1 Drug	Drug Classification	\$2,500 & 90-day suspension
Infraction Class 2 Drug	Drug Classification	\$2,000 & 45-day suspension
Infraction Class 3 Drug	Drug Classification	\$1,500 & 30-day suspension
Infraction Class 4 Drug	Drug Classification	\$1,000 & 15-day suspension
Infraction Class 5 Drug	Drug Classification	\$750

*All prizes, ribbons and prize money won by the horse at the competition must be returned to the competition organizing committee where the infraction occurred.

*The PR will be placed NGS for the duration of the suspension and until all fines are paid in full.
